CODE OF CONDUCT

Elevated Legacy is a non-profit youth development organization that uses competitive basketball, community service and mentorship as vehicles to help its youth members achieve their highest potential as a student, athlete and as a citizen. These goals cannot be achieved without the participation and cooperation of parents, guardians and other adult and youth mentors.

This agreement is intended to establish and sustain a positive environment for the youth who participate in our program. As a parent/guardian of a youth participant:

- I will encourage good sportsmanship by demonstrating positive support for all players, coaches and officials at every practice, game or other Elevated Legacy events.
- I will place the emotional and physical well-being of my child ahead of my personal desire to win.
- I will support the coaches and officials working with my child in order to encourage a positive and enjoyable experience for all.
- I will demand a sports environment for my child that is free from drugs, tobacco, alcohol, foul language, and refrain from their use at all events.
- I will remember that the game is for the youth – not the adults.
- I will encourage my child to treat other participants, coaches, fans and officials with courtesy and respect regardless of race, sex, creed or ability.
- I agree to bring any concern or complaint I have to my child's head coach.
- I understand that parent involvement is critical to the organization's success. I agree to assist and participate in fundraising activities

PLAYERS CODE OF CONDUCT

Being a member of East Bay Legacy means more than just learning about and playing basketball. As a player, both on and off the court, you are a representative of your club and are expected to act accordingly. No matter what the circumstances, always conduct yourself with pride and poise.

As an Elevated Legacy player:

- I understand that my education must come first and that I must maintain my grades in order to play.

- I understand that missing practice(s) and/or giving less than 100% effort impacts my development, my playing time and my team.
